Fr. Michael Baggot was received into the Catholic Church on the Easter Vigil of 2003, after a high school conversion from agnosticism. He then graduated *summa cum laude* from Christendom College with a B.A. in Philosophy, before working in Rome as a Resident Director for the school's study abroad program. In 2013, he received a Licentiate in Philosophy



summa cum laude from the Pontifical Athenaeum Regina Apostolorum in Rome. In 2017, he received a Baccalaureate in Sacred Theology *summa cum laude* from the same institution. Prior to entering the seminary, Baggot reported on prominent bioethical issues as a reporter. He spent his initial period of seminary formation near Cologne, Germany. He later worked as an assistant for the *Curso de Hispanidad* in Mexico City and as a teacher at Pinecrest Academy in Atlanta, Georgia, before returning to Rome for further studies. He has worked as the Correspondent of the UNESCO Chair in Bioethics and Human Rights from 2011-2019, during which time he has penned articles for the organization's website and for the scholarly journal *Studia Bioethica*. In 2015, he began contributing to the journal of religion and public life *First Things*. In 2016, he began teaching in the Faculty of Philosophy at the Pontifical University *Regina Apostolorum*. In 2016-2017, he also acted as a tutor of the *Sinderesi* program that aids university students in the discernment of contemporary social issues. Baggot received *summa cum laude* for his doctoral dissertation "Transhumanism, Thomism and True Perfection: A Thomistic Evaluation of the Admirable Aspirations and Lamentable Limitations of the Technocentric, Postmodern, Secular, Liberal Worldview of the Oxford Transhumanists" at the Pontifical Athenaeum *Regina Apostolorum* in the Faculty of Bioethics in June 2021. He is currently Assistant Professor of Bioethics at Regina Apostolorum and Adjunct Professor of Theology at the Christendom College Rome program. He is also Research Scholar at the UNESCO Chair in Bioethics and Human Rights in Rome, Italy. His writings have appeared in *First Things*, *Studia Bioetica*, *The National Catholic Bioethics Quarterly*, and *Medicine, Health Care and Philosophy*. He is editor of and contributor to the book [*Enhancement Fit for Humanity: Perspectives on Emerging Technologies*](#) (Routledge, 2022).

Transhumanism, Thomism, and True Perfection: A Thomistic Evaluation of the Admirable Aspirations and Lamentable Limitations of the Technocentric Secular Postmodern Worldview of the Oxford Transhumanists

- Summary of doctoral research: Transhumanism is the logical development of a secular humanist materialism that has spawned recent schools of radical self-invention like transgenderism. Transhumanism's frightening advocacy of human self-extinction in the name of evolutionary development should shift our analysis from the critique of any given Silicon Valley proposal toward the underlying philosophical presuppositions that motivate intelligent men to invest large sums of money in endeavors that seem like the stuff of science fiction scripts. The criticism of the secular humanism that undergirds transhumanism also provides the opportunity to see how the Thomistic synthesis offers a surprisingly relevant response and corrective to the fantasies of the techno movement. In short, this thesis is a critical analysis of transhumanism as a technocentric secular postmodern worldview in response to which the Thomistic integrated vision of the natural moral law virtue ethics offers a



sure path to the human improvement transhumanism purports to provide. Hence, the work does not pretend to be an exhaustive study of all the themes of transhumanism nor the contributions of all of the movement's major authors. Likewise, a detailed treatment of all intra-transhumanist debates among proponents of the movement regarding nuances of the worldview is beyond the scope of this present study. The work will cite a wide variety of authors to illustrate key tenets of the technocentric secular humanism that informs the movement. In particular, the present study will give a certain privileged attention to the Oxford School of transhumanism insofar as Nick Bostrom, Julian Savulescu, and their collaborators usually provide the most systematic philosophical presentation of key points of the transhumanist worldview. Likewise, the text will draw heavily upon contemporary Thomistic thinkers to assess the legitimate desires for transcendence in the transhumanist outlook and as a corrective to the limits of the technocratic secular vision. Again, the present work does not aim to resolve the numerous disputed questions among Thomistic thinkers. Instead, the present study proposes a creative retrieval of Thomistic thought to present a richer vision of human flourishing and a sure guide to transcendent bliss that both fulfills and surpasses the expectations of the transhumanist worldview. Thus, the Thomist does not induce the secular transhumanist to suppress his aspirations for greatness; instead, he invites the wayward transhumanist to cultivate and order his desires toward the true goods that will bring him the eternal life for which he only confusedly but rightfully longs. Overall, this work provides a unique presentation of how the Thomistic synthesis of metaphysics, natural theology, anthropology, and virtue-centered ethics overcomes the limited perspective of the dominant technocratic paradigm to show man's unique dignity and destiny for beatitude.
