#### Licentiate

Cycle II or **Licentiate** corresponds to a **Master's Degree**. The Courses for the Licentiate are developed in two ways:

- Weekly Courses**, which take place throughout the semester, from Monday to Friday;
- Intensive Courses**, which take place over two intensive weeks per semester

**Modality:** on-campus.

**Duration:** 2 years (120 ECTS)

**Language:** Italian (and English only during the Intensive Courses).

#### Doctoral Program

In-depth research on a topic of Bioethics and writing of the doctoral thesis, under the guidance of a faculty member, in which the student produces a publication that is personal and original.

## TOPIC AREAS

### LICENTIATE

- Biomedical area:** general and cellular biology, fertilization, gestation and development, anatomy and human physiology, genetics, the physician and the medical profession, history and philosophy of medicine.
- Philosophical/theological area:** metaphysics, logic, philosophy of knowledge, general ethics, philosophical anthropology, history of philosophical thought, introduction to theology, fundamental moral theology.
- Legal area:** introduction to law and philosophy of law, constitutional law and political organization, criminal law, private law, public international law.
- Bioethics area:** general bioethics, bioethics and sexuality, bioethics technology and procreation, bioethics and respect for unborn life, bioethics and medical interventions on humans, bioethics and management of the medical act, bioethics of psychology and psychiatry, bioethics and risky behavior, bioethics and end-of-life issues and euthanasia, bioethics state and society, communication in bioethics, bioethics and ecology, research methodology.

### MASTER IN GLOBAL BIOETHICS ONLINE & MAESTRÍA DE ESTUDIOS DE BIOÉTICA EN LÍNEA

- Bioethics area:** concept of the human person in bioethics and global ethics, trends and currents of thought in bioethics, bioethics and human sexuality and reproduction, bioethical and clinical aspects at the end of life, bioethics and health management/health policies, global bioethics, health public, bioethics and the environment, intercultural dialogue in global bioethics, research ethics and accountable science, ethical foundations of bioethics, emerging technologies and bioethics global: neuro-nano-info technologies.
- Medical area:** clinical and bioethical aspects at the beginning of life, bioethics and the medical act.
- Legal area:** bioethics and biological law, global bioethics and international human rights: the right to health care, bioethics and social problems.
- Philosophical area:** the concept of human being in bioethics, epistemology and argumentation, ethical foundations of bioethics.
- Research area:** research methodology in bioethics, research techniques and databases.
